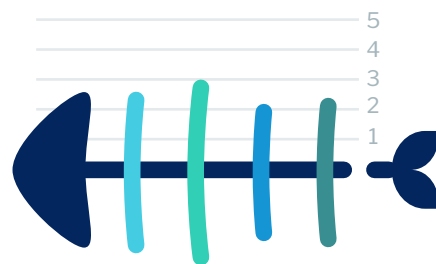

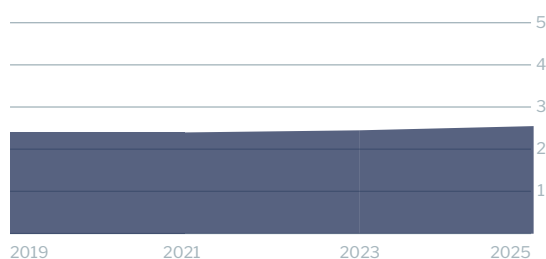

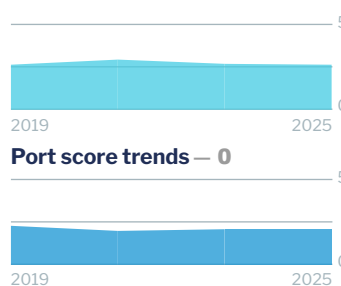

2023 - 2025 change ▲ 0.09



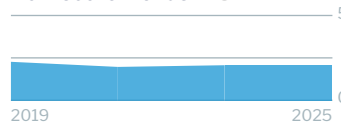
Coastal score trends ▼ 0.06



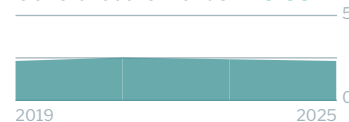
