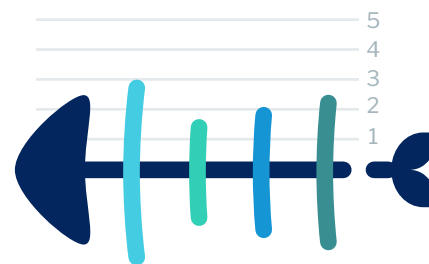

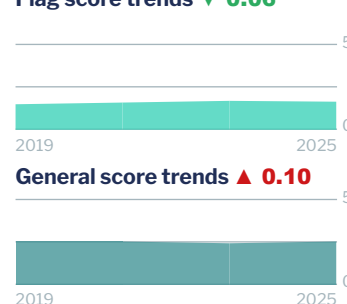

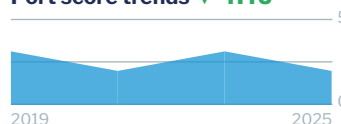
Coastal score trends ▼ 0.13



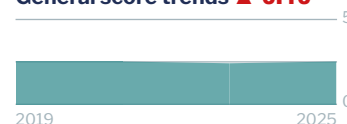
