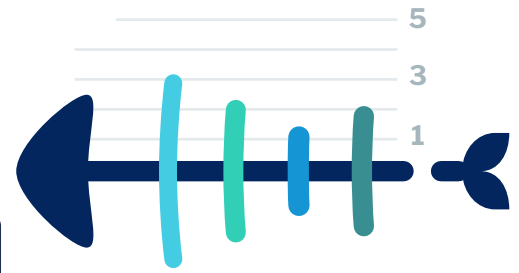

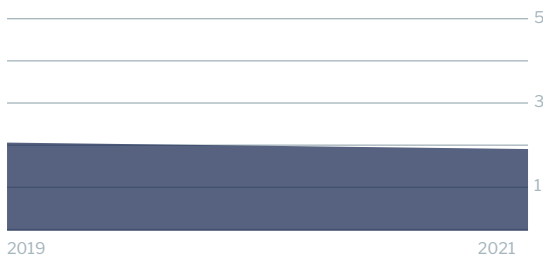

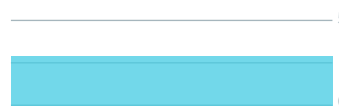

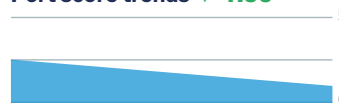

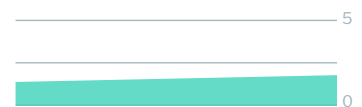
Coastal score trends — 0



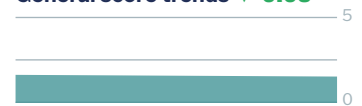
Port score trends ▼ 1.56
